#### **Social Justice Ireland Report: Delivering Deliberative Democracy**

This Social Justice Ireland launched "Delivering Deliberative Democracy: Participation by the Public Participation Networks in Local Government Decision-Making".

The purpose of this research was to capture how the various PPN stakeholders engaged in the participation processes 'on the ground' viewed the application of the principles set out in the Council of Europe Framework to participation by the PPN, both overall and at each stage of the decision-making process.
